All active members, 13 years of age and older, are asked to perform a minimum of five hours of labor per year on an approved project or during one or more of our designated "Work Days" at Quarry Lake, Prior Lake or Spring Lake. All members pay a work fee of \$100 (\$150 for family membership) in advance to create an incentive for members to fulfill their labor obligation. **Please include A SEPARATE CHECK for \$100 (\$150 family) along with your membership payment. Please date your check November 1, 2010.** YOUR CHECK WILL BE HELD UNTIL NOVEMBER, 2010 AND CASHED ONLY IF YOU DO NOT FULFILL YOUR 2010 LABOR REQUIREMENT. If you fulfill your labor requirement, we will destroy your check. **If you know now that you will be unable, or if you prefer not to fulfill your labor obligation in 2010, please check here _____** and we will cash your Work Fee payment upon receipt. Types of Membership

Active: An Active Member is required to have an active 2010 USA Waterski Membership in addition to the Shakopee-Prior Lake Shockwaves (Shockwaves) Membership. An Active Shockwaves Member may use Club facilities on Prior Lake and Spring Lake, and may use Club facilities on Quarry Lake during designated Open-Ski times. When invited to do so by a Quarry Lake Member, any Active Shockwaves member may also ski or board with a Quarry Lake Member during his/her assigned time-slot on Quarry Lake. Active SPLWSA Members must sign the Quarry Lake Release and Waiver.

Non-Active: A Non-active Shockwaves Member CANNOT participate in any USA Waterski sanctioned event, Shockwaves ski event, practice, Quarry Lake time-slot, or use Shockwaves equipment including, but not limited to, Quarry Lake, boats, docks, jumps and skis. This Member has voting rights, is welcome to come watch practice or events at Quarry Lake, receives the Club newsletter and is invited to banquets and other social functions. Any person without an active USA Waterski Membership is automatically a non-active Shockwaves Member. Non-active Members must sign the Quarry Lake Release and Waiver.

Release and Waiver

In consideration of my being able to participate in activities or use equipment of the Prior Lake Waterski Association (PLWSA), dba the Shakopee-Prior Lake Waterski Association, dba Shockwaves, I hereby for myself, my heirs, executors and administrators, release and forever discharge the PLWSA, their directors, members, agents, servants, and persons connected with the PLWSA, of and from any and all rights, claims, demands, and actions whatsoever that I may have for any and all loss, damage, or injury sustained by me or my equipment during any such activities.

PLWSA Membership may enable me privileges to participate in certain PLWSA activities at Quarry Lake or to visit Quarry Lake to watch PLWSA activities. I acknowledge that the Quarry Lake property is owned by the City of Shakopee (City) and made available to and used by the PLWSA under a Use Agreement between the City and PLWSA which defines PLWSA Member rights and obligations at Quarry Lake. I understand that there is only one approved way to access the Quarry Lake site, and that is via private roadways owned by Aggregate Industries, Inc. and via land leased to Aggregate’s subcontractor, Bituminous Roadways, Inc.

In return for these Quarry Lake access and use privileges, I hereby for myself, my heirs, executors and administrators, release and forever discharge the City of Shakopee (City), Aggregate Industries, Inc. , (Aggregate), Bituminous Roadways, Inc., (BR), and PLWSA, their directors, members, employees, agents, servants, and all other persons connected with the City, Aggregate, BR, and PLWSA, of and from any and all rights, claims, demands, and actions whatsoever that I may have for any and all loss, damage, or injury sustained by me or my personal property in connection with my attending or participating in activities at Quarry Lake.

I certify that I have received and read a copy of both the rules for use of Quarry Lake, including the Quarry Lake Boats/Engines Policy, and the Environmental Report concerning Quarry Lake. I have received a copy of the SPLWSA Directions to Quarry Lake, promise to enter and exit the site only by the route specified therein, and to see that others who ski during my time-slot do the same. I agree to be responsible to see that those that ski with me at Quarry Lake are active SPLWSA Members. I understand and agree to take responsibility for the risks, rules and obligations of using Quarry Lake, and I agree to take responsibility that those in my Quarry Lake skiing party will do so as well.

I agree to perform at least five hours volunteer labor during organized Work Events at or for Club facilities on Quarry Lake, Prior Lake, or Spring Lake during 2010; or, I agree to pay a Work Fee of \$100 per Individual (\$150 family) to fulfill my labor obligation.
